Fees

- In the case of disclosure and notification of intended use, a handling fee of 1,000 yen (consumption tax included) will be charged for each request.
- Fee payment method
Once your identity has been verified using the Disclosure Request Form and identity verification documents, we will contact you separately to notify you of the bank transfer account and request that you remit the prescribed fee. Bank transfer fees shall be borne by the individual.

[Notes]

- [1] If the Disclosure Request Form is incomplete, we may not be able to process the disclosure.
- [2] If we are unable to verify the identity of the individual or the representative's authority, we may not be able to process the disclosure.
- [3] Even if the results of the investigation indicate that we do not possess the individual's personal information, the fee will not be refunded.
- [4] We may withhold the information in part or in full if there is a possibility of significant hindrance to the proper conduct of our business, or if required by law. The fee will not be refunded in such cases.
- [5] We will make the decision on whether to disclose the information and notify the individual of our judgment.
